What Is a SHIP?

The State Health Insurance Assistance Program, or SHIP, is a Federal grant program that helps States enhance and support a network of local programs, staff, and volunteers. Through one-on-one personalized counseling, education, and outreach, this network of resources provides accurate and objective information and assistance to Medicare beneficiaries and their families. This allows the recipients to better understand and utilize their Medicare benefits.

SHIPs help beneficiaries identify and understand programs and plans, including Medicare prescription drug coverage, Medicare Advantage plans, Medicare supplemental insurance policies, Medicare Savings Programs, long-term care insurance and financing, and other public and private health insurance coverage options. SHIPs also assist eligible participants in enrolling in these programs and plans.

BIOGRAPHY OF SHIP DIRECTOR Ms. JUDITH CRAWFORD

Ms. Crawford has served as the Vermont SHIP director for the past 9 years. She is responsible for all facets of the program's performance. During her tenure, she has overseen the expansion of the program to more than double its original size and has helped the Vermont SHIP become a nationally recognized program.

Ms. Crawford also has served in leadership roles beyond her work in leading Vermont SHIP. She cofacilitates the MMA Task Force Work Group with Brendan Hogan, the deputy commissioner of DAIL, and has served in a leadership capacity with the national SHIP program. For 3 years she served as chair of the SHIP Steering Committee. Prior to her work as steering committee chair, Ms. Crawford served as a member of the 1-800-MEDICARE and SHIP Program Standards subcommittees.

SHIP HIGHLIGHT

In March 2008, Vermont SHIP was chosen as one of four national SHIPs to participate in the Collaborative State Project sponsored by the Health Assistance Partnership (HAP), a subsidiary of Families U.S.A. Local program staff are working with HAP to create a new volunteer model for Vermont, leading to the recruitment and training of additional volunteer counselors who will be available to assist SHIP staff during the Medicare prescription drug open enrollment period each year. HAP program staff will help Vermont SHIP define specific roles for volunteers, including outreach, counseling, data entry, and partnership development.
